SUBJECT: Occupational Studies Originally Scheduled for Implementation on 7/1/09

During the past biennium, staff in the Compensation & Classification Division completed four occupational group studies, all of which were scheduled for implementation on July 1st of this year. Per regulation, occupational studies become effective when the funding is provided by the Legislature in the biennial operating budget for the State. The Legislature recently concluded its 2009 session, and funding for implementation of the studies was <u>not</u> provided. As a result, the occupational studies will not be implemented and positions in the studies will remain classified as they are now.

For clarification, the revisions recommended for the following class specifications will not be implemented:
