SUBJECT: NEW CLASSIFIED AND UNCLASSIFIED COMPENSATION

SCHEDULES

The 2007 Legislature, in SB 575 approved a 4% cost of living adjustment (COLA) for classified and unclassified State employees effective July 1, 2008. There are no changes to the retirement contribution at this time. Pay Policies 1 through 12 have been updated to reflect the COLA and are attached for your convenience. The COLA does not impact the pay for Elected Officials, Pay Policies 30 and 31. All compensation schedules can be found on the Department of Personnel's website at http://dop.nv.gov/compschedules.htm.

RETAINED RATE PROCESSING

- Employees on a retained rate for less than two years as of July 1, 2008, that have an employment status of "M" are eligible for the 4% increase which will be automatically generated by the system; no ESMT-A is needed.
- Employees currently with an employment status of "M" that have been on a retained rate for two years or more as of June 30, 2008, and the employment status has not been updated to a "U" will be overpaid. To avoid this, an ESMT-A needs to be submitted updating their employment status to a "U" code using the Personnel Action/Reason Code of STCHG, and the effective date must reflect the two-year

expiration date. The current salary information needs to be included on the ESMT-A not to reflect the 4% COLA.

Employees on retained rate with an "N", "R", or "U" employment status are not eligible for a 4% increase; therefore, an ESMT-A is not needed.

UNCLASSIFIED and NON-CLASSIFIED PROCESSING

An appointing authority has the option to set the salary for unclassified and non-classified employees at or below the authorized maximum salary approved by the Legislature. The 4% salary increase will be systematically generated for all unclassified and non-classified employees. If the agency wishes to set the salary at a rate different than the 4% increase over the current salary, an ESMT-A must be submitted. The ESMT-A must have the effective date of July 1, 2008, and the Personnel Action/Reason Code COLA/M09. Additionally, a notation must be made under the "Remarks" section indicating, "This action reflects a change to the cost-of-living adjustment".

ESMT PROCESSING DEADLINES

Since July 1, 2008, falls in Pay Period 02, all ESMT-A documents referenced in the above text must be entered into ADVANTAGE-HR and submitted to the Department of Personnel, Central Records, no later than the normal deadline of July 15, 2008. Entry for Pay Period 02 cannot begin until Tuesday July 8, 2008. Central Records staff will need to verify the COLA implementation after the pay cycle runs for Pay Period 01. Any transaction with an effective date of June 30, 2008, for Pay Period 02 will need a July 1, 2008, COLA/M09 back up document.

It is mandatory that the SUSE file be clear before the close of business on July 3, 2008. Beginning at 4:00 p.m., July 3, 2008, Central Records staff will delete all entries in SUSE with a status of NT PR, REJCT and PD AP. If there are any transactions in SUSE after 5:00 p.m. on this date, the COLA will not be applied to those employees with pending transactions. We would greatly appreciate your assistance in monitoring the SUSE file to ensure all of your transactions are processed.

Turn-around documents reflecting the July 1, 2008, 4% increase will be generated for employees who are unclassified, classified medical, non-classified or on a retained rate after the Central pay cycle on July 18, 2008. Once your agency has received the turn-around documents, they are to be reviewed by your agency Personnel Liaison for any required adjustments, which must be submitted by the Pay Period 03 Central Records deadline. Please note in the "Remarks" section of the ESMT, "This is a correction to the 7/1/08 COLA action".
