SUBJECT: Revision to PERD #24/07 - Three Grade Increases

This memo is written to revise PERD #24/07 regarding the "Special Processing Instructions" for those Title Codes receiving a three-grade increase. After additional analysis, it has been determined that NAC 284.170 subsection 2. (a) should not be applied to the class titles receiving a three-grade increase due to the fact that this is an **equity adjustment** granted by the Legislature. Attached you will find a listing of Title Codes to which this applies. It should be noted that three-grade increases resulting from Occupational Studies **must** follow the guidelines set forth in NAC 284.170.

The "Special Processing Instructions" in PERD #24/07 relating to this subject matter are no longer valid. The three-grade adjustments will be systematically generated with no special documentation (ESMT) requirements. However, we are aware that some agencies may have already processed paperwork for these adjustments. Dependent upon where these documents are in the processing cycle, please take the following action:

- If ESMT's have **NOT** been completed No further action is required.
- If ESMT's have been completed and not transmitted to Central Records Change the Action Code to "ORDTA", cross out any changes you have made, and submit to Central Records for processing. This code will initiate a new turnaround document in preparation of future changes.

• If ESMT's have been completed and submitted to Central Records for processing – The Action Code will be changed by our staff to "ORDTA" and all other changes will be crossed out. A new turnaround document will be produced and sent to the agency in preparation of future changes.
