The mission of the Aging and Disability Services Division (ADSD) is to provide leadership and advocacy in the planning, development and delivery of a high quality, comprehensive support service system across the lifespan to allow all of Nevada's elders, children and adults with disabilities or special health care needs, to live independent, meaningful and dignified lives to the greatest extent possible.

This **position** provides advocacy and education relating to the legal rights of older persons and persons with disabilities. The incumbent shall facilitate the development of legal services to assist older persons and persons with disabilities in securing and maintaining their legal rights; provide, upon request, technical assistance, training and other support relating to legal rights; review tand develop policies and regulations, legislation and regulation that will effect our consumers; review and analyze information relating to abuse, neglect, exploitation, isolation or abandonment of our consumers; access records and represent our consumers; appear as amicus curiae on behalf of our consumers; and perform other functions as necessary to carry out the duties of the office of the Attorney for Rights of Older Persons and Persons with Disabilities.

This is a Governor appointed position in the unclassified service. The incumbent will serve at the pleasure of the Administrator of Aging and Disability Services Division.

**EDUCATION AND EXPERIENCE:** Applicants must be an attorney licensed to practice law in the State of Nevada. The applicant must also have documented education and experience which demonstrates the ability to successfully perform the duties and functions of this position.
