## Chief Game Warden Full-Time Unclassified Position

Annual Salary: Up to \$97,901

Employee/Employer Paid Retirement. An Employer-Paid Retirement is available with a reduced annual salary.

**Recruitment Open To:** All qualified persons

**Location:** Reno Nevada with limited statewide travel

Applications Accepted Until: Position is Filled

**Benefits:** Paid medical, dental and vision care; life and disability insurance; 11 paid holidays; 3 weeks each of annual and sick leave; State retirement system; and an optional tax-deferred compensation plan. State employees do not contribute to Social Security but must contribute to Medicare.

The Chief Game Warden commands a staff of 55 including a force of 39 game wardens, the law enforcement dispatch center, radio communications and boating education throughout the state. The position is responsible for strategic planning, policies, regulations, legislation, budgets and training of sworn and non-sworn personnel. The Chief supervises, evaluates performance and ensures proper training of assigned personnel; directs internal investigations, special field operations and complex investigations.

## **Qualifications:**

 Bachelor's degree from an accredited college or university in wildlife management, biology, criminal justice or closely related field and five years of responsible professional experience in the enforcement of wildlife and boating safety laws and regulations. Experience must have included at least two years of supervisory experience developing proposals and recommendations, budget administration, supervision of staff and program planning; OR an equivalent combination of education and experience.

## **Special Notes/Requirements:**

- Applicants must meet Peace Officers' Standards and Training (POST) as established in the Nevada Revised Statutes and Nevada Administrative Code;
- Pursuant to NRS 284.4066, this position has been identified as affecting public safety. Persons offered employment in this position must submit to a pre-employment screening for controlled substances.
- A State of Nevada/FBI background will be required of the selected applicant.

**Location:** This position is located in Northern Nevada at Headquarters in Reno. Reno is home to the University of Nevada Reno, Morrison College and Truckee Meadows Community College.
