**SPECIAL NOTIFICATIONS:** This position is exempt from the provisions of State of Nevada Classified service. Selection shall be made by, and the incumbent shall serve at the pleasure of the Executive Director. This position starts on or after October 3, 2016.

**POSITION SUMMARY:** The Chief Operations Officer has a lead role in establishing the Silver State Health Insurance Exchange's (SSHIX) strategic and programmatic priorities and managing the agency to ensure it achieves its mission.

### RESPONSIBILITIES INCLUDE:

- Assist the Executive Director set strategic priorities for the SSHIX in consultation with the Board of Directors and agency staff.
- Manage agency operations to ensure the achievement of strategic priorities and day-to-day Activities.
- Oversee allocation of staffing resources and support desired outcomes for agency priorities
- Lead planning and implementation teams for agency projects as needed
- Oversee budget development and financial operations for the agency
- Support the Executive Director in policy-making to include addressing practical aspects of national health care reform's impact on the SSHIX.
- Represent the SSHIX at forums and meetings to educate stakeholders and the public about the agency and state and national health care reform.

**SALARY AND BENEFITS:** Salary range is up to \$108,393 (employer/employee paid retirement). Employee benefits include paid annual leave, sick leave, health insurance, and state retirement benefits. Other optional benefits are available, including a deferred compensation package.
