The Department of Conservation and Natural Resources is seeking qualified candidates for the position of Administrator of the Nevada Division of Outdoor Recreation, a new division within the Department established through Assembly Bill 486 of the 2019 Legislative Session. This is an appointed position that serves at the pleasure of the Director of the Department of Conservation and Natural Resources. This is a full-time, exempt unclassified position.

POSITION SUMMARY: The Administrator is responsible for directing and supervising all administrative, fiscal, budget and technical activities, as well as all programs administered by the Nevada Division of Outdoor Recreation.

Responsibilities include serving as head of the Division; serving as the Executive Director of the Advisory Board on Outdoor Recreation; collaborating with a variety of public, private, and nonprofit organizations to advance outdoor recreation and business development; marketing and promoting Nevada's vast recreational opportunities; applying for and administering outdoor recreation grants; and ensuring a healthy and sustainable outdoor recreation economy that centers on protecting natural resources, among numerous other responsibilities.

APPROXIMATE ANNUAL SALARY:

Salary up to \$95,931. (Salary range reflects Public Employees' Retirement System contributions by both the employee and employer. An employer paid contribution plan is also available with a reduced gross salary.)

BENEFITS:

The State benefits package includes a retirement system; paid health, vision, dental, life and disability insurance; 11 paid holidays; and paid sick and annual leave. Other employee benefits such as deferred compensation plans are available.

REPRESENTATIVE DUTIES:

- Organize the Nevada Division of Outdoor Recreation and assign responsibilities and duties to staff.
- Adopt regulations as needed for carrying out the provisions governing the Nevada Division of Outdoor Recreation
- Serve as Executive Director to the Advisory Board on Outdoor Recreation.
- Recommend policies and initiatives to the Director of the Nevada Department of Conservation and Natural Resources to enhance outdoor recreational amenities and experiences in Nevada, and help implement such policies and initiatives.

- Coordinate with the various divisions and programs within the Nevada Department of Conservation and Natural Resources, including, but not limited to, the Nevada Division of State Parks, Nevada Division of State Lands, Nevada Off-Highway Vehicles Program, Recreational Trails Program, the Nevada Tahoe Resource Team, and Nevada Conservation Districts Program on matters related to conservation and natural resources.
