# **Position Responsibilities**:

The Southern Nevada Operations Manager reports to the Executive Director for the Nevada State Board of Massage Therapy. This position is located in Las Vegas. This position will assist the Executive Director with all Board functions conducted in Clark and Nye counties including sanitation inspections, establishment licensure, office administration, Board meetings, representing the Board at both schools and professional association meetings, and testifying on behalf of the Board at legal proceedings. The Southern Nevada Operations Manager will be responsible for the day-to-day supervision of all Board staff located in the Southern Nevada office. Candidates must possess the following qualifications:

- Ability to work independently.
- Experience with supervision and management.
- Communication skills including public speaking and the ability to write reports.
- Critical thinking and the ability to evaluate processes and make recommendations for streamlining Board practices and improving efficiencies.
- Ability to insure compliance with NRS 640C and NAC 640C.
- Understanding of the massage industry and the operation of establishments in Southern Nevada including spas, private practices and outcall services.

- Time management skills and the ability to coordinate projects with other staff members
