### **Senior Program Analyst**

This is an open competitive recruitment, open to all qualified persons.

#### **Recruiting For:**

A permanent full-time vacancy located at the Nevada Gaming Control Board, Administration Division, Carson City, Nevada.

#### **The Position:**

Under the direction of the Programming Supervisor, the position's primary responsibility is application development for the Nevada Gaming Control Board. This involves all aspects of development, from business process analysis and requirements gathering, to implementation including designing, developing, testing, debugging, documenting and production support. The qualified individual will assist in creating application development strategies, developing and administering applications and performing related work as required.

#### **Description:**

The qualified individual will participate in designing, developing, testing, debugging, and documenting software applications and that support the mission of all Board Divisions including;

- Apply knowledge of development techniques and technology to satisfy user requests and application development objectives
- Lead efforts with business users and the technical team to review current applications and procedures and develop business and technical requirements
- Design technical and business process flowcharts, data models and entity relationship diagrams based on business and technical requirements
- Utilize documented requirements to develop applications and systems

#### **Primary Requirements:**

Candidates must have a minimum of four years' experience with application design and development using Visual Studio development tools including ASP.Net, C# and the MVC framework. Four years' experience with Microsoft SQL Server 2008 or above and JavaScript is required. An in depth understanding of Microsoft operating systems and its related tools and applications is also required. The ideal candidate will have experience developing in JQuery and XML, using development tools such as Toad or similar tools and experience with

development collaboration systems such as Team Foundation Server. Experience developing in Jasper Reports Crystal Reports and SQL Server Reporting Services is desired.

Candidates must have excellent oral and written communication skills as well as experience with formal QA processes and coding standards.

This position is a fulltime employee position, no contractors will be considered.

**Other Requirements:**

- Advise Information Technology Management on policy decisions affecting the delivery of business information systems to the Gaming Control Board.
- Help identify and implement best practices as they relate to application development in existing and future Board development projects.
- Ability to lead application development projects through to completion.
- Work with internal and external customers in defining business needs and identifying cooperative relationships to improve business processes.
- Help establish security policies and procedures for applications.
- Meet on a regular and timely basis with IT management, project managers, and staff as needed to ensure proper communication flow, project status, and implementation schedules.
- Ability to interface with a wide variety of users to determine business requirements. Ability to translate business requirements to efficient, useful applications.
- Resolve issues presented by management, staff, and business users regarding work processes, policies, procedures, and methods.
- Strong interpersonal, communication, and project management skills are critical to the job.

**Knowledge of:** Principles, organization, planning, project management, and current computer industry technology and practices; principles of information systems design, application development, operations, and controls.
