SUBJECT: Recruitment and Layoff Information

I wanted to provide some additional information regarding the communication that was sent out last week from the Department of Personnel (DOP) concerning the hiring freeze. I would also like to offer some training opportunities in the event we are forced to reduce staff through the layoff process.

The announcement last week that placed a hold on all hiring activities was implemented as a proactive step to manage the on going challenges relative to our decreasing revenues. As you recall, the Director's Review Panel must approve all positions not on the exempt list before a candidate can be appointed. If a recruitment was open as of May 16, 2008, it will remain on the NVAPPS website and applications will be received. The DOP Recruitment and Retention Division will also continue to conduct applicant testing and compile eligibility lists for these vacancies. We will not stop recruitment for the 407 positions we currently have open, but rather we will put a hold on hiring in case some of these positions are approved for hire.

We understand you may be approached with questions and concerns from employees regarding the possibility of layoffs. We feel it is important for all Agency leaders and Personnel Liaisons to be prepared to address this subject if economic conditions continue to decline. The DOP will be offering several training sessions to provide information regarding the State's layoff process. These classes will cover the following topics:

- Beginning of Layoff Process
- Seniority/Calculating Seniority
- Layoff Notices/Displacement
- Deductions
